Kling reviewed city code on tree removal within the right of way. Milam reported finish work and training on the generator has yet to be completed; streets signs are being replaced; both Brandt & Gary have been to training Monday and Tuesday; the report on lead & copper lines within City limits is almost complete and ready to send to the State; and he has located 5 of 9 shuts off's for fire hydrants.

Meningococcal Secondary School Vaccine Requirement

All students entering, advancing or transferring into 7th grade and born on or after September 15, 2004, will need proof of one dose of meningococcal conjugate vaccine (MenACWY). All students entering, advancing, or transferring into 12th grade and born on or after September 15, 1999, will need proof of two doses of meningococcal (A, C W, Y) vaccine; or 1 dose if received when the student was 16 years of age or older.
